Webster Woman Drowns By Normandie Blake, Monitor Writer

WEBSTER – A 36-year-old woman from Webster died yesterday afternoon in a boating accident on Walker Pond.

According to Webster Police Chief Aime Roy, Carole Warren was in a canoe photographing the foliage near her home when the accident occurred. He speculated that she might have stood up to take a picture and tipped the boat over.

Her husband, Michael, was splitting wood. He notices floatation cushion, then saw her floating on the pond. He swam to her, pulled her to shore and began trying to revive her.

The Webster police department received the emergency call at 2:44 p.m. Help also came from the Boscawen and Hopkinton police departments, the Webster fire department and Merrimack County sheriff's department.

Cardiopulmonary resuscitation was given until 5:25 p.m., when she was pronounced dead at Concord Hospital.

(Chief) Roy said the New Hampshire fish and Game Department would send divers into the pond today to try to find the camera. He said the camera might give the police some idea of what happened.

Mrs. Warren was employed as a nurse practitioner in Laconia. She leaves her husband; two children by a previous marriage, Kathy and Frank Loto; and her parents, Mr. and Mrs. William Bird of Miami, Florida.

Her husband is employed by R&T Electric INC. in Concord.

Carole was a 1963 graduate of Chatham (NJ) High School.
